

### How the Plan Works

You authorize GM Financial to make automatic withdrawals for contractual payments from a bank account selected by you on approved payment dates over the term of your contract. The last payment may be more or less than the scheduled payment depending upon your schedule. You will receive prior notice if the final payment amount is more than 25% of the contractual payment amount.

### How to Set Up

Complete the Pre-authorized Debit ("PAD") Authorization section of this form and return the completed form along with one of the following supporting documents:

- An unsigned blank cheque with "VOID" written in ink across the front or,
- A completed Pre-authorized Debit Form from your financial institution providing your account information

<p>This authorization is provided in connection with payment of amounts due under the GM Financial Account Number identified above (the "Contract"). The undersigned accountholders ("you" and "your") hereby authorize GM Financial on its own behalf or as an agent for any assignee to make withdrawals from your bank account set out on the attached "Void Cheque" or any other bank account that you may identify to GM Financial from time to time (the "Account") for: (i) the amount of each payment due under the Contract on or shortly after its payment due date (each, a "Scheduled Debit Date") as set out in the Contract; and (ii) any other amount that may become due under the Contract from time to time (including, without limitation, interest on overdue amounts, default charges, and NSF charges) on the next Scheduled Debit Date. You understand that the withdrawal for the last payment may be more or less than the scheduled payment, depending upon the payment schedule. If your Scheduled Debit Date falls on a weekend or holiday, you agree that GM Financial may debit the Account on or shortly after the next business day. You acknowledge that GM Financial may contact you to obtain a separate authorization for any withdrawal on a date that is not a Scheduled Debit Date. If any debit is dishonoured by your bank for any reason, you agree that GM Financial is entitled to issue another debit in substitution for the dishonoured debit. This authorization is to remain in effect until GM Financial has received written confirmation from you of its change or termination. You may cancel this authorization upon ten (10) days' written notice to GM Financial before the next Scheduled Debit Date; however you remain obligated to pay to GM Financial all amounts due or owing under the Contract. You may obtain a sample cancellation form, or more information on your right to cancel this PAD agreement at your financial institution or by visiting <a href="http://www.payments.ca">www.payments.ca</a>. You have certain recourse rights if any debit does not comply with this PAD authorization. For example, you have the right to receive reimbursement for any PAD that is not authorized or is not consistent with this PAD authorization. You consent to the disclosure to GM Financial and GM Financial's financial institution of any personal information relating to the Account. <b>GM Financial may assign this authorization to another person or entity without notice to you, unless notice is required by law. You understand that GM Financial will not notify you in advance of any withdrawal and you agree to waive all pre-notification requirements in respect of all withdrawals to be drawn under this authorization.</b></p>
